### **What Are Professional Standards?**

To understand the importance of this specialized software, it's key first to understand what constitutes Professional Standards. Many agencies model their programs after the Standards of Conduct established by the International Association of Chiefs of Police (IACP). Adopted in 2019, these standards encompass a broad range of topics including the law enforcement code of ethics, statements of values and mission and clear expectations of conduct both on and off duty.

Aligning with national or provincial frameworks is a way public safety agencies can foster transparency. When the public sees that an agency is guided by recognized standards and a clear commitment to integrity, trust can grow. And that trust

is a key pillar of the foundation for effective community partnerships which are a necessity for the success of modern policing and public safety.

### **The Impact of High Standards on Daily Operations**

Consider an officer involved in multiple incidents involving use-of-force over a short period such as three months. If high standards are in place and specifically warn against such patterns of use, the behavior can be flagged for review. Without a threshold policy that triggers review, such incidents may go unexamined. Research demonstrates that departments with transparent complaint systems see a 20 to 30 percent decrease in repeat misconduct.

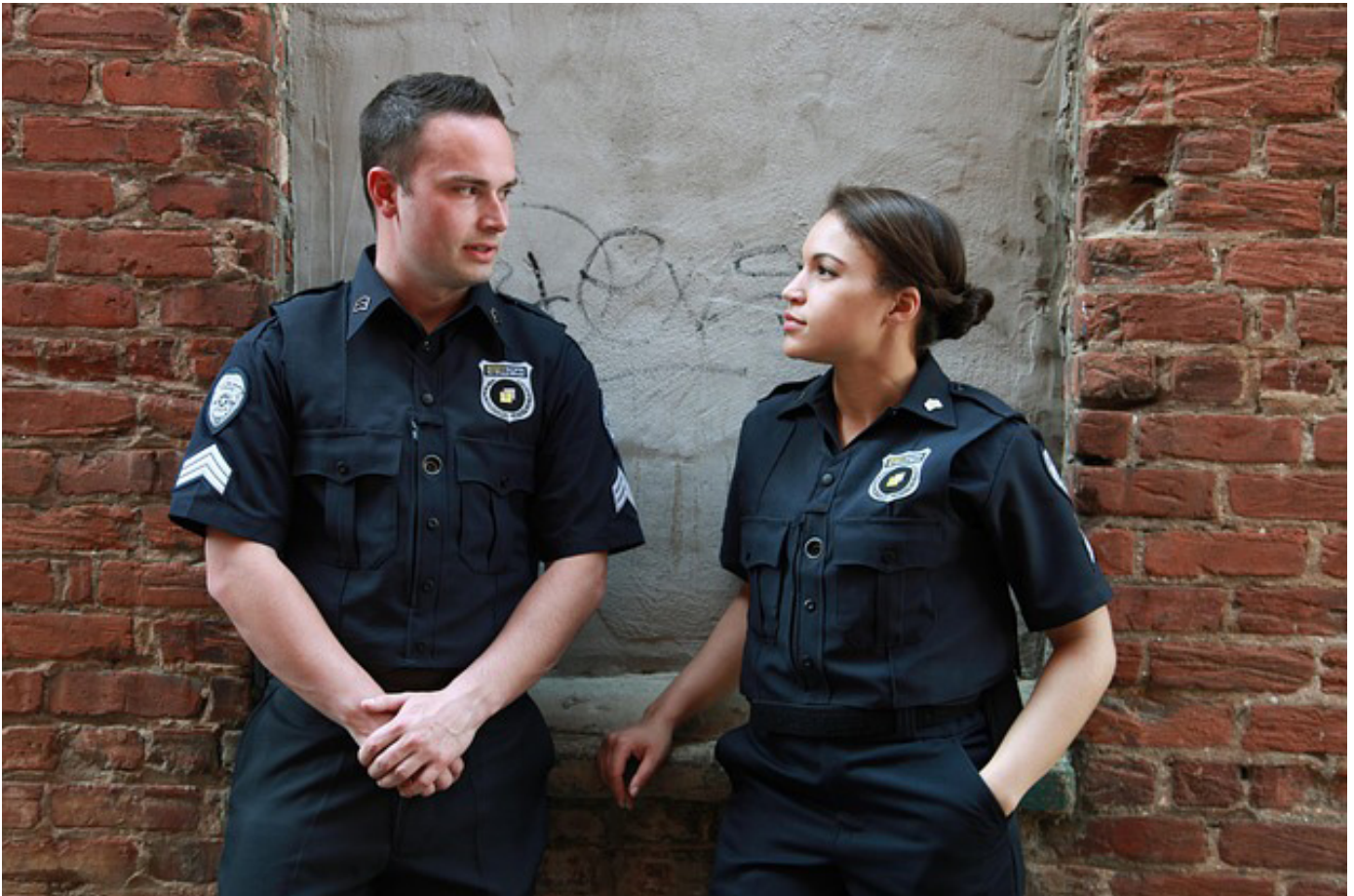
Likewise, if your standards are designed to improve call handling, incident response and interagency

coordination, they can promote consistent, credible patterns of behavior across your agency. Accountability in public communications is also a key tool for establishing credibility and building trust with community members.

### **Building a Culture of Accountability and Growth**

Your frontline team members face enormous pressure to act quickly and optimally. By establishing clear expectations and providing continuous feedback, you equip your staff to deliver the essential services the public expects. Without that foundation, morale can decline, turnover may rise and service quality could suffer, which is a lost opportunity for both your agency and your community.
